Project Ref: Rehabilitation of Feeder Roads in the Volta Region

- The Millennium Challenge Corporation (“MCC”) and the Government of Ghana the (the “Government”) have entered into a Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Ghana (the “Compact”) in the amount of approximately 547 million USD (“MCC Funding”). The Government, acting through the Millennium Development Authority (MiDA), intends to apply a portion of the MCC Funding to eligible payments to specific project proposed for “**Rehabilitation of Feeder Roads in the Volta Region**” under the contracts for which this Invitation for Bids (“IFB”) is issued. Any payments made under the proposed contract will be subject, in all respects, to the terms and conditions of the Compact and related documents, including restrictions on the use of MCC funding and conditions to the disbursement of MCC funding. No party other than the Government and the Employer shall derive any rights from the Compact or have any claim to the proceeds of MCC Funding.
- MiDA now invites sealed bids (“Bids”) from eligible and qualified entities or persons (“Bidders”), who possess and fulfill the Qualification Requirements as described in Section III. Evaluation and Qualification Criteria of each respective Bidding Documents, for this proposed, specific Project comprising the following three Contract Lots:

- Multiple and combinations of lots and discounts are permitted within this Project package **only** under this IFB and will be evaluated on the basis of a contract or a combination of contracts or as a total of contracts in order to arrive at the least cost combination for MiDA by taking into account discounts offered by Bidders in case of award of such contracts. If a Bidder submits several successful (lowest evaluated substantially responsive) bids, the evaluation will also include an assessment of the Bidder’s capacity to meet the aggregated requirements of all such lots.
- This IFB follows the General Procurement Notice for this project that appeared in dgMarket online, UN Development Business online, local newspapers i.e. Daily Graphic and Ghanaian Times on 18th February, 2009 and was posted on MiDA website: www.mida.gov.gh .
- A Contractor for each Contract Lot will be selected under a competitive bidding method, the evaluation procedure which is described in the Bidding Documents, in accordance with the “MCC Program Procurement Guidelines” which are provided on the MCC website at www.mcc.gov.
