**Invitation for Bids**

**Supply & installation of Personal Computers and Accessories for  
Rural and Community Banks in Ghana.**

1. The Millennium Challenge Corporation (%MCC+) and the Government of the Republic of Ghana (the %Government+) have entered into a Millennium Challenge Compact (the %Compact+) for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Ghana in the amount of approximately five hundred and forty seven million USD (%MCC Funding+). The Millennium Development Authority (%MiDA+) on behalf of the Government intends to apply a portion of the proceeds of MCC Funding to eligible payments under a Contract associated with this Bidding Document. The interpretation and performance of the Contract, including payments by MiDA and restrictions on the use of MCC Funding, will be subject, in all respects, to the terms and conditions of the Compact. No party other than the Government and MiDA shall derive any rights from the Compact or have any claim to the proceeds of MCC Funding.
2. This Invitation for Bids follows the General Procurement Notice that appeared in dgMarket on 9<sup>th</sup> July 2008
3. MiDA now invites sealed Bids to provide the Goods and Related Services shown above. More details on the requirement are provided in the Schedule of Requirement.
4. This Bid is open to all eligible Bidders who wish to respond the Bidding Document. Bidders may only associate with each other either under a joint venture relationship, or under a sub-contractual agreement to complement their respective areas of supply to enhance their capacity to carry out the Supply and Installation Contract.

**The Bid and the Contract to be awarded is for the Supply, installation and maintenance of Personal Computers and Accessories for Rural and Community Banks in Ghana. The total quantity of PCs and UPS's required will be 1082 distributed to 541 RCB Rural Community Banks (RCBs) and Branches as per the Schedule of Requirement SR1 in this document. The PCs, UPS's and Accessories are to be supplied, installed and commissioned in Lots as detailed in this document. Bidders are permitted to bid for all or any of the Lots but the bid must be for complete Lots. The maximum number of Lots awarded to any one bidder may, at MiDA's discretion, be limited to one (1) Lot. The Bid must include all costs involved in the supply, delivery, installation and commissioning of the PCs, UPS's and Accessories. The Bid must include the cost of a one (1) year warranty and a Maintenance Agreement for two (2) years following the expiration of the warranty period.**
