2.0 OPENING

The Procurement Agent Manager opened the meeting at 09:30 hours, welcomed all present and thanked them all for attending the Meeting. He then read out the Technical Scores of those who have qualified and then separated the Financials of those who qualified from those who did not.

3.0 PROCEDURE FOR OPENING

The following procedure was adopted for the opening:

- the Financial Offer envelopes were inspected to ensure that all documents were present, intact and still sealed and not tampered with;
- the envelopes containing the Financial Offers of those Firms that have not attained the requisite pass marks to qualify at this stage were set aside;
- the Financial Offers of those Firms who attained the requisite pass marks to qualify at this stage were opened, numbered and date-stamped;

- the Financial Offers were then checked as complete and signed and then the Total Financial Offered Prices were read out;
- the Read Out Prices were counter-signed by Representatives of the Firms present;
- Copies of the Read Out Prices were signed and distributed to Firm Representatives present;
- the Minutes of the Public Opening of Financial Offers were recorded which were then to be circulated to the Firms at the earliest opportunity.

The Record of Financial Proposal Prices Read-Out is attached as Annex II.

4.0 CLOSING

The Procurement Agent Manager, in closing, thanked all present for their participation, and indicated that the Evaluation Panel would commence immediately. He, however, hoped that Bidders would make themselves available over the coming days should there be clarification questions from the Panel which require urgent responses.
