



SUMMARY OF THE 27TH SPECIAL MEETING OF THE BOARD OF DIRECTORS OF THE MILLENNIUM DEVELOPMENT AUTHORITY

JANUARY 31, 2019

12:00 P.M., FIESTA ROYALE HOTEL, ACCRA

The following is the summary of the 27th Special meeting of the Board of Directors of the Millennium Development Authority ("MiDA") held at the Fiesta Royale Hotel, North-Dzorwulu, Accra on the above-mentioned date and time and for which Notice was duly given in writing on January 30, 2019.

The meeting was convened pursuant to (i) the Millennium Challenge Compact between the United States of America, acting through the Millennium Challenge Corporation ("MCC"), and the Government of the Republic of Ghana (the "Government"), executed on August 5, 2014 (the "Compact"); and (ii) the Program Implementation Agreement, by and between the United States of America, acting through MCC, and the Republic of Ghana, dated August 5, 2014 (the "PIA").
