GENERAL PROCUREMENT NOTICE No. 5

The Republic of Ghana (the “**Republic**”) and the Millennium Challenge Corporation (“**MCC**”) have entered into a Millennium Challenge Compact for Millennium Challenge Account assistance to help facilitate poverty reduction through economic growth in Ghana (the “**Compact**”) in the amount of Four Hundred and Ninety Eight Million, Two Hundred Thousand United States Dollars (US\$ 498,200,000) (“**MCC Funding**”) and Thirty Seven Million, Three Hundred and Sixty Five Thousand United States Dollars (US\$37,365,000) (“**Republic Funding**”). The Government of Ghana (“**GoG**”), acting through the Millennium Development Authority (“**MiDA**” or “**MCA Entity**”), intends to apply parts of the proceeds of the funds to payments for Contracts for Goods, Works and Services.

The procurement program for the period 1st October 2016 to 31st March 2017 will include the following:

* Vehicles
* Office Equipment

Procurement of IT Services (Non-Consulting Services) in:
<i>Component 1: ECG Financial Turnaround (Modernization of Utility Operations of ECG) which include:</i>
* Installation of a Geographical Information System (GIS) based Distribution Management System, Grid Digitization and Customer Census to record and store data.
* Services of IT consulting firm for the Installation of Enterprise Resource Planning (ERP) System and the Integration with existing enterprise applications.
Procurement of Consultancy Services in:
<i>Component 1: ECG Financial and Operational Turnaround Project - Modernization Utility Operations Activity sector - and include:</i>
* Technical Assistance Services for ECG in such areas as Program Direction and Monitoring, Planning and GIS Implementation, Loss Control and Co-ordination between Call Centre and Dispatch Centres.
* Services of a Design Consultant to assist in the upgrade of the Data Centre and Communications Network of ECG to be compatible with current industry standards.
* Consultancy for Installation of Outage Management System
* Services of an Individual consultant to assist in the Institutionalization of Gender Responsiveness to Support the Development of Gender Policy at ECG and an Internship and Mentoring Program (NEDCo option)
* Services of an Environmental and Social Performance (ESP) Consultant. (IDIQ)
* Services of a Resettlement Action Plan Consultant. (IDIQ)

* Services for the Development of a Power Sector Capacity Scan
<i>Component 6: Energy Efficiency and Demand Side Management Project which include:</i>
* Services of a Consultant to assist in the “Race to Retrofit and Renewal Program”.
* Services of a Consultant for Street Light Design, Technical Specifications, Works Supervision, Commissioning and DLP.

Component 8: Programme Administration and Oversight which include:

* Services of an External Auditing Firm to audit MiDA Activities for a specified period

Contracts for Goods, Non-Consultant Services, IT Services, Works, and Consultancy Services financed under the program will be implemented according to the principles, rules and procedures set out in the MCC Program Procurement Guidelines which can be found at the MiDA website. The Procurement is open to all bidders from eligible source countries as defined in the MCC Program Procurement Guidelines.
