



GHANA POWER COMPACT

- Compact US\$ 498.2m plus 7.5% Government contribution.
- Compact signed 5th August 2014
- Entry into Force 6th September 2016
- Compact End Date 6th September 2021 (Note that no MCC funds can be used on any work that continues after this date)
- Compact Close Out 4th January 2022 (120 days later)



Procurement Plans 1

- An annual Procurement Plan is drawn up which covers all activities MiDA intends to start (i.e. issue a Specific Procurement Notice (SPN)) within the year.
- The annual Plan is to enable businesses worldwide to plan well in advance to target those activities which are of interest to them.
- The Plan is approved by MiDA Management, the MiDA Board of Directors, and the Millennium Challenge Corporation (MCC).
- The Plan is then updated every three months to add new activities and to remove those which have commenced.


General Procurement Notice

- Once a Procurement Plan has been approved MiDA issue a General Procurement Notice which informs business of the activities approved for competition.
- The GPN is advertised on MiDA, dgMarket, UNDB Online, Invest in Africa (APP) and the Public Procurement Authority websites as well as in the local media.
- If organizations are interested in any specific opportunities on MiDA GPN's then they should send an email to <u>paghana@charleskendall.com</u> with the relevant contact details (Contact person(s), email address(es), full name and address of company and phone numbers) <u>and list the</u> <u>specific activities of interest</u> so we can send you and your contacts the specific SPN's when the activities start.

COMMENCEMENT OF PROCUREMENT

Once an activity is ready to be issued into the market place:

- When Shopping is the procurement method then the RFQ is issued to an approved short list of firms. The short list can contain those who are already on the short list for the 'requirement(s)' concerned as well as those who have expressed interest in the activities.
- Otherwise MiDA issues a Specific Procurement Notice for open competitive Procurement and the SPN is placed on the MiDA, dgMarket, UNDB Online and Invest in Africa (APP) Websites and in the local media. The SPN is also sent by email to all those firms who responded to the GPN and included the procurement being launched in the list of activities in which they were interested.



- Procurement Agent to ensure integrity of the process
- Fiscal Agent to approve and process payments
- Open competition wherever possible
- No geographic or national preferences
- Government Owned Enterprise eligibility on Goods, IT Systems, Works
- Independent and suitably qualified Evaluation Panels
- MCC and MiDA Board of Directors approvals over certain thresholds
- Price Reasonableness Analysis
- Contractor Past Performance Reports and References
- Bid Challenge System (www.mida.gov.gh) and Debriefings

SOLICITATION DOCUMENTS

MCC STANDARD BIDDING DOCUMENTS ARE BASED ON IDA/WORLD BANK STANDARD DOCUMENTS BUT ADAPTED TO SUIT MCC.

REMEMBER THIS IS UNTIED AID AND COMPETITION IS OPEN WORLDWIDE.

IMPORTANT FOR INTERESTED BIDDERS TO READ THE SOLICITATION DOCUMENTS CAREFULLY AS MCC HAVE ISSUED NEW VERSIONS IN THE LAST YEAR.

IF IN DOUBT ON ANY ISSUE(S) ALWAYS ASK FOR CLARIFICATION BY THE ADVERTISED DEADLINE.

Note: Sole Source Selection and Direct Contracting is allowed but only when fully justified and approved in advance by the MiDA Board of Directors and MCC.

KEY TIMELINES 1

Pre-Bid/Proposal Meeting – Open to all interested Bidders. Minutes of the meeting and presentations will be made available to all.

Clarification Questions and Responses – The Bid/Proposal Data Sheet will state the deadline by which questions must be received and the date and time (17:00 hours in Ghana) by which MiDA is to issue responses to all questions received without identifying the Bidders.

Always attend the pre-Bid/Proposal meetings to learn about the activity and then ensure that questions are sent on time by email to <u>paghana@charleskendall.com</u> with a copy to <u>procurement@mida.gov.gh</u>.

KEY TIMELINES 2

SUBMISSIONS DUE BY **10:00 Hours (Works) 15:00 hours (Goods, IT Systems, Consultancy)** GHANA TIME ON THE DATE STATED IN THE SOLICITATION DOCUMENT. A PUBLIC OPENING FOLLOWS IMMEDIATELY AFTER.

LATE SUBMISSIONS WILL NOT BE ACCEPTED.

COMMON CHALLENGES

- Clarification questions not asked by due date and time.
- Courier packages or Bids/Proposals not clearly marked clearly label courier packages with activity title and IFB/RFP reference number.
- Proposal submission form/letter (TECH-1) not signed.
- Power of Attorney not provided.
- JV or Association documents not provided.
- Government Owned Entity form not completed and/or signed.
- Financial Statements not provided.
- Firms respond to Requirements/TORs stating they will do what the Requirements/TOR requires but not explaining how they will carry out the assignment.
- Firms fail to analyze the evaluation criteria and align the marks available to the content of their Bid/Proposal.
- References and/or contact email addresses not provided for Bidder and/or Key Personnel.
- Technical/Financial forms not responded to, or completed, in full.
- CV not signed, or years of experience for Key Personnel not clear.
